3. Presentation & Approval of Balance Sheet (FY 2024-25)

- Presented by Mr. Deepak Agrawal, Treasurer.
- The audited balance sheet had been circulated two weeks before the AGBM.
- Members were informed that the Governing Body was available at the RWA office on 31 July 2025 to address queries, but no member availed the opportunity.
- During the meeting, one member disrupted proceedings. He was informed that answers to his
 emailed queries were ready, but he left midway without listening. He was again invited to
 review ledgers at the RWA office as per bye-laws.
- · Proceedings continued with remaining members.
- The balance sheet was approved by 39 of 43 members present. One member walked out and three abstained.

4. Budget for FY 2025-26

a) Construction of Toilets

- Two toilets: one for staff, one for residents (near backup area).
- Estimated cost: ₹2,00,000.
- Status: Approved

b) Lighted Signages in All Lanes

Status: Approved

c) GST Registration

- To be reviewed with Chartered Accountant.
- Status: Under Consideration

d) Amendment/Revision of RWA Greenwood City Bye-Laws

- Since the existing bye-laws were framed in 2014 & amended in 2018, it has been unanimously
 felt that these require revision in order to align with present-day needs, objectives, and to
 ensure compliance with the latest Haryana Registration and Regulation of Societies (HRRS)
 Act.
- Status: Approved
- A Committee of Five Residents will be constituted to prepare the draft revised bye-laws. The draft will then be placed before an Extraordinary General Body Meeting (EGBM) for consideration and approval by the residents.

e) Stray Dog Menace

- Concerns raised regarding increasing dog bite cases.
- Suggestions:
- Construction of dog shelter near water boosting station (subject to MCG approval) proposed by Mr. Vinay Gupta (C-68).
- Prohibition of stray dog feeding on roads; fines to be imposed suggested by Mr. Navdeep Singh (C-61, 3rd Floor).
- Installation of cautionary signage.

f) Pet Registration

• Mandatory for all pet owners as per Government of Haryana guidelines.

g) Clarification on RWA Responsibilities

- Query by Mr. Satyen Mittal (C-80).
- Members were informed:
- Non-essential services fall under RWA.
- Essential services (water, electricity, garbage, roads) fall under MCG/DHBVN, with RWA acting only as a coordinator.

h) Electricity Panel Repair (Query by Mr. Satyen Mittal, C-80)

Clarified that RWA is not responsible; only DHBVN can carry out such infrastructure repairs.

i) Conduct of Residents - Defamation Issue

- Ms. Shruti Agrawal (C-18), Returning Officer for 2025 Governing Body Elections, reported defamatory remarks made against her on a WhatsApp group post-election.
- She reserved the right to pursue legal action.
- Similar remarks had earlier been made against another Governing Body member by the same resident. GB reserves the right to pursue legal action.
