Meeting Proceedings

The meeting commenced at **11:00 AM** after confirmation of the **required quorum**.

1. Welcome Address

Ms. Vineeta Khosla, President, welcomed all members and thanked them for their presence. She then invited **Ms. Vanita R. Agarwal, General Secretary**, to proceed with the agenda.

2. Work Report (September 2025 – December 2025)

Presented by: Ms. Vanita R. Agarwal, General Secretary

The work report highlighted the following key achievements and issues:

- Successful organization of **Children's Day and other cultural events**, which were highly appreciated by members.
- **Cleaning of the green belt outside the colony** was carried out and applauded by all. Members were informed that the GB had met GMDA officials and submitted an application for this work in April 2025. A complaint was also registered on the GMDA portal; however, no action was taken. Consequently, the GB undertook the cleaning work independently.
- **Security-related issues** and the associated expenses were discussed in detail. It was unanimously agreed that the current security setup represents the minimum essential requirement for the society.
- It was suggested that **ID cards for part-time helpers and domestic staff** be issued at the earliest.
- Submission of an application to **DHBVN for installation of an electricity connection** for the RWA office was proposed and approved by members.
- A request for installation of **monkey bars for children** was raised by residents and approved.
- Installation of **additional CCTV cameras** was suggested for areas such as the park and gym, and approved. Installation of a CCTV camera at the main gate was proposed to monitor and deter wrong-side driving, which has been increasing and poses safety risks. This was also approved.

- Detailed discussions were held on issues related to the maintenance of the **water boosting station and DHBVN electricity panels**. Members were apprised of the crisis during the Diwali period due to the installation of an electricity panel by B Block. It was informed that the issue was resolved through **consistent follow-up by the GB with MCG authorities**. A separate smart panel for C Block Street lights has since been installed by MCG.
- The GB reiterated its commitment to pursue concerned authorities for the upkeep of essential services such as water and electricity. It was clearly stated that **RWA funds will not be utilized for such services unless in cases of utmost emergency**. Approval for this decision was sought via a show of hands and was unanimously supported.
- Members were once again requested to refrain from sharing official RWA communications outside the designated group, in order to maintain the integrity of official information.

Members appreciated the efforts of the RWA and provided constructive feedback.

3. Presentation of Financial Status (as on Date)

- The current budget position of the RWA was explained to the members.
- Members were requested to **encourage non-members to enroll and share responsibility** towards the colony.
- It was announced that the **annual subscription will remain unchanged at ₹25,000 for the financial year 2026–2027**.

4. Vote of Thanks

Ms. Vanita R. Agarwal, General Secretary, expressed sincere gratitude to all members for their active participation and valuable suggestions.

- Appreciation was extended to **MCG and DHBVN authorities** for their cooperation.
- Special thanks were conveyed to the **RWA staff** for their dedicated service.

The meeting concluded with refreshments for all attendees.


